# Tentipi Arctic Adventure Activity terms and conditions

# 1. Agreement to Terms

By participating in any activity provided by Tentipi, you agree to abide by the terms and conditions outlined in this document.

# 2. Assumption of Risk

I understand that the activity I am about to engage in involves certain risks, including but not limited to: freezing temperatures, snow, sleeping in tents, handling open fire, operating terrain vehicles, using knives, axes and fishing gear, being on frozen lakes, encountering wildlife, and living in the wilderness far from civilization. I acknowledge that this list is not exhaustive, and there may be other inherent risks associated with the activity. I voluntarily assume all risks associated with the activity and agree that Tentipi is not liable for any injury, damage, or loss that may occur during the activity.

### 3. Health and Fitness

I certify that I am over 18 years of age, physically and mentally fit to participate in the activity, and do not have any medical conditions that may jeopardize my well-being during the activity. I agree to inform Tentipi in advance of any health concerns or changes in my health status.

### 4. Driver's License Requirement

To participate in the activity, it is essential to be physically and mentally capable of operating a snowmobile. Tentipi will provide instructions, eliminating the need for prior experience. I confirm that I possess a valid driver's license suitable for driving a car in Sweden, as this is a prerequisite for operating a snowmobile in the country. Please note that the activity does not involve driving a car.

### 5. Personal Insurance Declaration

I affirm that I hold a valid health insurance policy that provides coverage for, but is not limited to, accidents involving terrain vehicles and ambulance transport facilitated by helicopter. It is crucial for participants to verify that their insurance coverage adequately addresses the potential risks associated with the activity. Additionally, I acknowledge that any costs not covered by my insurance will be my sole responsibility.

# 6. Code of Conduct

I agree to conduct myself in a respectful and responsible manner during the activity. Tentipi reserves the right to terminate my participation if my behaviour is deemed inappropriate or potentially dangerous, and no refund will be provided.



# 7. Dietary Requirements

Tentipi aims to provide safe and enjoyable dining experience for all participants. We acknowledge that individuals may have specific dietary requirements or restrictions. It is your responsibility to inform us of any dietary preferences, allergies, or restrictions at the time of booking the activity. While we strive to accommodate various dietary needs, please note that we may not be able to guarantee complete exclusion of specific allergens or meet highly specialized dietary requests.

# 8. Alcohol and Substance Policy

Participants are prohibited from bringing their own alcohol or any substances classified as drugs to the activity. Tentipi provides limited quantities of alcohol as part of dinners. Tentipi reserves the right to deny participants access to alcohol if it is deemed to jeopardize the well-being and safety of any participant during the activity.

# 9. Booking Finalization and Refund Policy

When booking through Tentipi website, an invoice is e-mailed to the participant's inbox. The booking process concludes with the payment of the invoice. A complete refund of 100% is available for cancellations made until January 10th, 2024. Regrettably, as of January 11th, 2024, refunds will not be facilitated.

Participants are strongly advised against booking non-amendable flights or other travel arrangements around the activity before January 11th, as Tentipi Arctic Adventure is contingent on reaching a minimum number of participants. On January 11th, 2024, we will reassess and confirm all participants' bookings. Please exercise caution and consideration of these policies when making travel arrangements.

### 10. Changes and Cancellations by Tentipi

Tentipi reserves the right to cancel or modify the activity in unforeseen circumstances. Participants will be promptly notified, and options to reschedule or receive a refund will be presented. It's important to note that interest will not be accrued on refunded amounts.

Participants are responsible for any costs associated with flights or other travel arrangements to and from the activity. Tentipi will not cover these expenses incurred by participants. Please take this into consideration when making travel arrangements.
